» CEPANI SECRETARIAT FULLY OPERATIONNAL DURING THE COVID-19 OUTBREAK

The CEPANI Secretariat is **fully operational** and manages its services by remote though our offices are closed as from Monday 16 March to Friday 17 April inclusive. This is, until further notice, the date set by the Belgian government. This exceptional measure has been imposed on us and is part of a "force majeure" situation with which we must all show solidarity.

We therefore **favor exclusive electronic and phone communication**. If necessary, paper copies can always be deposited at the reception desk of the VBO/FEB, rue Ravenstein 4, 1000 Brussels.

Vereisen de overheidsmaatregelen die op 12 maart laatstleden werden genomen dat wij onze kantoren sluiten. Echter, garanderen wij **de continuïteit van onze werkzaamheden** achter gesloten deuren, en dit van 16 maart tot en met 17 april aanstaande. Dit is, tot nader order, de door de Belgische regering vastgestelde datum. CEPANI now offers on its website an user-friendly costs calculator for CEPANI arbitrations, on the basis of the value of the claim and the number of arbitrators to be appointed.

Arbitration

What is arbitration ?

The arbitration costs shall include the fees and expenses of the arbitrators as well as the administrative expenses of the Secretariat.

Rules

The fees and costs of the arbitrators shall be determined by the Secretariat depending on the amount in dispute and within the limits mentioned hereinafter.

Costs calculator

This scale (Schedule 1 of the Rules) applies to all proceedings introduced as from 1 January 2020 whichever version of the Rules is applicable to the proceedings.
